- *4 of the 5 kittens in the new FIV room tested negative on their 2nd test
- *Once the 3 rooms at the north end of the building are painted, they will become a "no cats allowed" area in the shelter
- *Most of the new office furniture has been installed
- *The fire alarm system is almost complete
- *A new Animal Care Technician has been hired
- *We are still working with Sheakley in our search for an Operations Manager
- *The Sheakey handbook has been recieved
- *Research has identified Walmart to be the best overall provider for shelter supplies
- *The report for The Bernard Foundation is being finalized
- *A bid has secured to repair the clogged patio drainage system for 5800(+/-) and the work will be completed by September 1^{st} , 2014

- *A volunteer recognition event is in the works
- *It was proposed that this year's Open House be held in 2 parts
 - 1- An "invitation only" event to be held on September 4th
 - 2- An "open to all" event to be held on September 14th

- *RoseAnn attended a "Cat Symposium" sponsored & hosted by HSUS and some corporate sponsors. She reported that it was very informative and enjoyable. She distributed a list of notes she took during the event.
- *A short discussion took place as to how some of the ideas presented during the event could be utilized to the best advantage of Cat Welfare

ESTATES

- *A successful Kitten Shower and small food drive took place
