# Help Us Replace the Last of the Old Cages

In the last few years, we have replaced most of the cages in the shelter with cat condos, making it much easier to clean up after and care for our feline residents. Now there's just one old unit of cages left, and after more than 15 years, it is ready to be retired.

The new bank of cages we'd like to order can be configured in multiple ways to house single cats, bonded pairs or litters of kittens. Plus, as with the condos, they will be easier to clean so we can keep everyone healthy. To complete this project we need to raise \$1,850. Can you help? ## FIV+ Cats Make Great Companions

Cats with Feline Immunodeficiency Virus typically don't have needs that are much different from any other cat. They should be kept indoors, eat a good, healthy diet and have as little stress as possible. Since FIV is only transmitted through deep penetrating bite wounds and blood transfusions, FIV+ cats can easily live in a home with FIV- cats. All cats in the household should have regular vet visits for their own health and to protect the health of the FIV+ kitty, since his or her immune system can have a harder time fighting off infections. The generosity of donors and friends, commitment of our members and volunteers, dedication of our staff, and leadership of our Board of Directors contributed to an outstanding year for Cat Welfare.

- **962** cats and kittens admitted to the shelter, many with life threatening injuries
- 1,039 felines adopted into loving homes, including 29 FIV-positive and 3 FeLV-positive kitties
- **208** kittens cared for in foster homes
- 2,419 altering surgeries subsidized through Cat Welfare's low-cost spay and neuter programs through November 2018
- **167** companion cats received medical care, supported by our Good Sam fund, when families could not afford

their cats' emergency medical treatment

• A comprehensive deferred maintenance project to enhance the lives of our shelter residents completed on time and on budget

- Two unique new T-shirt designs received rave reviews.

- The Catique Resale Shop celebrated its four-year anniversary at the Mediterranean location. Net proceeds help to fund shelter operations.
- Our Crime Cats Mystery Club, a program that offers children a
  way to gain confidence in reading while helping shy cats gain
  confidence around people, was presented with the OELMA Literacy Leader Award.


